Bury CCG Continuing Health and Complex Care -Current Landscape

- We currently work with 170 providers to facilitate the care of over 500 in area, and 600 out of area patients
 - 41 Domiciliary providers
 - 71 Care homes
 - 58 others
- Budget for 2022/23 for CCG of over £31m
- CCG' s Monthly spend for care:
 - £0.85m Care homes
 - £0.4m Domiciliary care
 - £1.45m others
- Why the move to SProc.Net?
 - Improved communication with providers
 - Simplified payments
 - Clearer oversight of package information for providers

Payments and Contract Management

- We will carry on distributing packages to our approved providers as usual.
- <u>SProc.Net</u> will be used to manage existing and future packages from the point of award. This includes making changes to packages where necessary and issuing payments.
- As a current Bury CCG provider, you will need to register on <u>SProc.Net</u> to be kept up-to-date on your packages, and submit invoices for payment.
- By doing so, you will benefit from a consolidated payments approach.
- Care provided up until the end of March 2022 will be paid using the current process. Care provided from April 1st will be paid through SProc.Net.


