- Current spend on Specialist Professional Services;
  - Approx. £4m per annum for Waltham Forest
  - Approx. £3m per annum for Redbridge
- Proposed Contract term 4 years







## **Current Provision & Issues**

- PS Procure currently purchase Specialist Professional services via multiple National Frameworks
- Traditional frameworks;
  - lack flexibility
  - prohibit the inclusion of new providers in the market
  - can hinder the inclusion of SMEs, local businesses & niche providers
  - inhibit innovation in service delivery
- Although compliant, this approach is now failing to deliver value for money solutions and is no longer fit for purpose
- With the changes made to IR35 legislation, we have identified an opportunity to source true consultancy and specialist services which delivers better VFM for us and greater opportunities for the supply chain







### **New Contract Outcomes**

- Demand for Professional Specialist Services across Waltham Forest and Redbridge continues in all sectors
- Need a supply chain, that can deliver services and projects across an increasingly diverse range of categories
- The outcomes required from the new contract are;
  - maximise compliance with Procurement regulations
  - deliver better VfM solutions than existing frameworks
  - improve control over Specialist Professional service need & our route to market
  - improve visibility of opportunity to a wider, more diverse supply chain, maximising competition







## **New Contractual Proposal**

- Implementation of a new Specialist Professional Services contract, managed through a Dynamic Purchasing System (DPS).
- 4 year contract
- Launches Early April 2018
